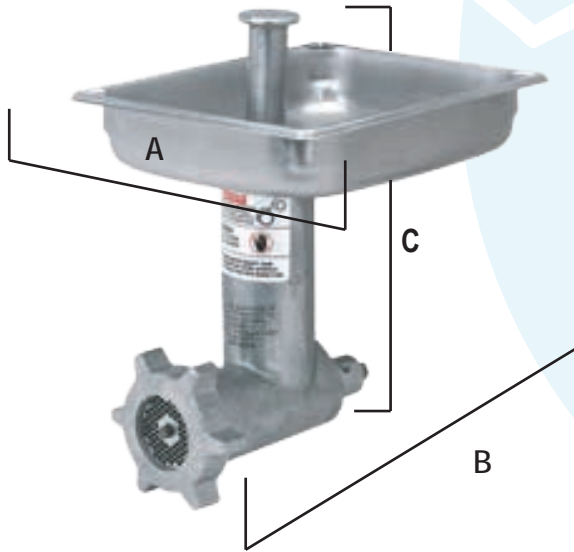

Mount: The ALMFC12 meat grinder is designed to fit into a #12 PTO (power take-off) hub.

Meat Grinder Housing: Aluminum housing with a #12 tapered hub. The housing is designed to be supported by and locked into a #12 PTO hub by a thumb screw.

Worm: Aluminum spiral flutes with a stainless steel shaft. Flutes are designed to shear and force the product into a hardened steel knife and through the sizing holes of the plate.

Feed Pan: Stainless steel.

Feed Stomper: Aluminum stomper designed for ease of handling and operator safety.
