Limited lifetime warranty

- Black Steel cookware, Bourgeat Excellence cookware, Matfer Whisks with Exoglass handle, stainless steel ladles and skimmers are protected by a limited lifetime warranty.

Five year warranty

- For select kitchen tools: 072770, 072890, 073095, 073135, 215304, 215306, 215312, 215408, 215431, the warranty period is 5 years

Two year warranty

- For Matfer Swing Salad Spinners 215580 and 215582, the warranty period is two years.

One year warranty

- All other Matfer Bourgeat USA products are covered by a one year warranty.

Matfer Bourgeat USA's obligation under this warranty is limited to repairing or replacing the qualifying product. The warranty covers faulty construction or materials when the product is used in home or commercial kitchen environments.

Claims must be submitted with the defective product and copy of the authorized Matfer Bourgeat USA dealer invoice. Return freight is the responsibility of the customer. No collect shipments will be accepted. Replacements will be shipped freight prepaid. Please allow four to six weeks for inspection and response.
